

## EASY FORMULA TO FIGURE OUT YOUR CHILD SUPPORT OBLIGATION

Below is the child support guideline table for Nevada. To better explain the table, we will look at two very simple examples.

**John and Jane have one child who lives with Jane full time and spends two weekends per month with John, as well as two weeks in the summer and some holidays:**

1. John's gross monthly salary is \$4,235.
2. Child support for one child is set at 18%, and 18% of \$4,235 is \$762.30, HOWEVER
3. Maximum child support per child for the range of \$0 to \$4235 is \$728 per month, therefore John will pay \$728 per month in child support.

**Now, in a second example, John and Jane are sharing physical custody of one child (one week with John, one week with Jane)**

1. John makes \$4,235 per month, so must pay \$728 to Jane as child support
2. Jane makes \$3,000 per month, so must pay \$540 to John as child support.
3. Difference between \$728 and \$540 is \$188, so John pays Jane \$188 per month.

Note that there are allowable deviations from child support. For instance, if John were paying all of the costs for the child's extracurricular activities and, or, paying private school tuition, in all likelihood, a deviation would be allowed and he wouldn't pay the full \$188 to Jane, and Jane might be expected to share in some of the costs of the extracurricular activities or school costs. This is a case by case basis.

### Statutory Percentages for Child Support in Nevada - NRS 125B.070 (1)(B):

One (1) child: 18%



**CHILD SUPPORT PERCENTAGES TO BE PAID:**

One (1) child: 18%

Two (2) children: 25%

Three (3) children: 29%

Four (4) children: 31%

Five (5) or more children: 2% more over amount for four (4) children for each additional child.

In Nevada, once you have a Decree of Divorce, if your spouse does not make the child support payments as ordered in the decree, you may contact Child Support Enforcement in the county where you reside. The District Attorney's Office will take legal measures to collect the child support through any means available to them, including wage garnishment, and bank account garnishment.
